

1. The envelopes should be subscribed will be "Tender for Sale of Dry Press Mud to be produced during the season 2019-20
2. Rate Ex-mills on "As is where is" basis.
3. Excise duty inclusive in quoted rates and Sale Tax/GST or other Govt Taxes, if any will be charged extra.
4. Insurance of press mud and its safe custody will be your responsibility.
5. Earnest Money Rs. 25,000/- (Rs. Twenty Five Thousand Only) will have to be deposited with tender and same amount shall be retained as security money of the successful bidder which shall be released after the successful completion of the contract.
6. The Tender without Earnest money will not be accepted.
7. Loading will be arranged by the successful bidder.
8. 100 % payment shall have to be deposited through DD/NEFT by you in advance before lifting of press mud.
9. Weighment of Trollies/Trucks will be done by the weighment committee at our own weighbridge and if will be considered as final.
10. The press mud is being sold with the condition that you will use it for Agriculture purpose only.
11. The Mills will have the right to with hold the lifting for pres mud for use in mills/production of bio-compost or for any other purpose.
12. The approximate press mud available for sale will be about 25000-30000 Qtls. Which may increase or decrease depending upon the availability of sugarcane for crushing.
13. The entire quantity will have to be lifted by the party. Quotations received for lesser quantity will be rejected.
14. Successful bidder will start the lifting of press mud after the closing of crushing season (2019-20) and will lift it, before 30.09.2020
15. If any eventuality occurs during work, the contractor has to bear the Loss/case.
16. The contractor will be responsible for compliance to the provision of labour laws including insurance, EPF Act and Family pension of labour engaged by him for which no extra payment will be made by the mills.

17. Tender will be open of those bidder only who will be participate in the tender of dry press mud of the production year 2018-19. Management have right to cancel the tender keeping in view the tender finalization of the sale of dry press mud of production year 2018-19.
18. TDS on GST will have to be deducted as applicable /into deuced w.e.f Ist Oct 2018 by Govt. of India under GST Act 2017 on supply /service rendered, of Rs. 2.50 Lac & above, as & wherever is applicable, from the bills of supplier/contractor & requisite certificate issued by GST Deptt.will have to be deposited with the mills.
19. Last date for submission of tender is 12.10.2019 up to 11.30 AM and negotiation with the highest tenderer will be held on the same day at 02.00 PM if required.
20. The mills management reserves the right to accept or reject any or all the tender without assigning any reason.Further committee reserves the right to alter any terms and conditions of the tender if required.
21. In case of any dispute jurisdiction will be Batala and MD Sugarfed Punjab or their nominee will be sole arbitrator .
